Greetings, Florida Chapter!

As I prepare to start my term as Chapter President, I am energized and inspired to advance our missing and to make a difference in the way our membership interacts with the Florida Chapter. In the 2014 ballot for my election, I outlined four goals, relating directly to our mission, that I will pursue during my term:

Continued Advocacy Excellence: The Florida Chapter is actively influencing the issues and legislation that affect Landscape Architects in Florida. I have been engaged with our government affairs committee and am in constant communication with our team to actively support or fight legislative issues. I am most proud that we have made great strides in partnering with our allied professions to work together on issues, rather than work against each other. We are currently engaged in a working group that involves representatives from other professional societies to work through a potential revision to aspects of CCNA. During Dave Ferris' presidential term, FLASLA placed landscape architect representatives on Urban Forestry Council board, an FDOT landscape industry advocacy group, and on the board for the Florida Coast to Coast trail. I will continue to seek opportunities to partner with our allied professions and to position landscape architects to influence all aspects of our profession.

Lastly, our Historic Landscapes lead and new ASLA Fellow, David Driapsa is actively seeking volunteers to help document Florida's historic landscapes. As Florida's population grows, it is important to encourage the documentation, preservation, and restoration of our historic landscapes. The 2016 HALS challenge is to document Florida's properties on the National Register of Historic Places. Look out for a call to participate soon!

- Advancing Effective Communication: The Chapter's communication to the membership through a variety of methods has been somewhat stale; this I endeavor to improve. I am excited that Adam McCollister will be our next Member at Large for PR and Marketing. His energy and passion for our profession is infectious, so look out for ways in which we will cultivate better social media output, improve upon our email newsletter, and establish more opportunities for membership interaction. - Education Options and Opportunities: I will work with Patricia Castellano, our Member at Large for Education and Research and Theresa Wymer, our new Education Committee Chair, to improve Chapter-sourced online learning opportunities and to maintain the high quality education sessions we provide at our annual conference.



I am also working with University of Florida and Florida International University representatives to better engage the Universities in our conference education session planning, determining potential opportunities for research partnerships, and improving FLASLA's interaction with the Student Chapters.
