Last month, ASLA cosponsored the Congressional Pollinator Protection Caucus briefing entitled "The Challenges and Opportunities for Pollinators in the United States" on Capitol Hill, and hosted a congressional reception at the Center for Landscape Architecture. Nearly 200 congressional and federal agency staff, coalition partners, and local landscape architects attended this highly anticipated annual event.

The Federal Trade Commission's newly created Economic Liberty Task Force will host a roundtable in Washington, D.C., on July 27 to highlight approaches that make it easier for workers in state-licensed occupations to offer their services across state lines or move between states. Government Affairs staff will be attending the event as well as working with the ASLA Licensure and State Advocacy Committee to submit public comments.
