ARTICLE 9. BOARD OF DIRECTORS

Section 9.1. Eligibility:

As a part of board member eligibility, it is preferred that all ASHHRA Board Members have their certification in health care human resources (CHHR), administered through Applied Measurement Professionals, Inc. (AMP). And it is required that all ASHHRA Executive Committee Members have their certification in health care human resources (CHHR).

Vice President – Three-year commitment to become president in 2016 and immediate past president in 2017. Must be an ASHHRA member in good standing for a minimum of five consecutive years and have served as a board member, chapter officer and/or committee chair for a combined minimum of three years. No member of the Board of Directors, including officers, may serve more than seven years cumulatively on the ASHHRA Board of Directors. It is required that all ASHHRA Executive Committee members be Certified in Healthcare Human Resources (CHHR).

Treasurer – (term expires 12/31/16). Must be an ASHHRA member in good standing for a minimum of five consecutive years and have served as a board member or committee chair for a combined minimum of three years. It is required that all ASHHRA Executive Committee members be Certified in Healthcare Human Resources (CHHR).

At-Large Board Member – (term expires 12/31/16). Two open positions. Must be an ASHHRA member in good standing for a minimum of three consecutive years with previous experience on an ASHHRA committee or task force desired.

Non-Hospital Health Care Director – (term expires 12/31/16). One open position. Must be an ASHHRA member in good standing for preferably three years (three years preferred, but not

required) with previous experience on an ASHHRA committee or task force desired.

Chapter Officer Director – (term expires 12/31/15). Must be an ASHHRA member in good standing for a minimum of three consecutive years and have been a chapter president or other chapter officer within the last five years.

Regional Director – (term expires 12/31/16). Must be an ASHHRA member in good standing for a minimum of five consecutive years with experience as a chapter board member in the last four years, or a current or former regional consultant.

New-to-the Profession – (term expires 12/31/16). Must be an ASHHRA member in good standing for a minimum of two consecutive years and a current practitioner in health care human resources for no more than five years. Previous leadership experience on an ASHHRA committee or task force is preferred.

Only practitioner members of ASHHRA who are currently practitioners (Article 6, Section 6.1.) in compliance with all provisions of the bylaws and who meet the criteria outlined for the position shall be eligible to serve on the Board of Directors of ASHHRA. **See the bylaws [here](#).**
