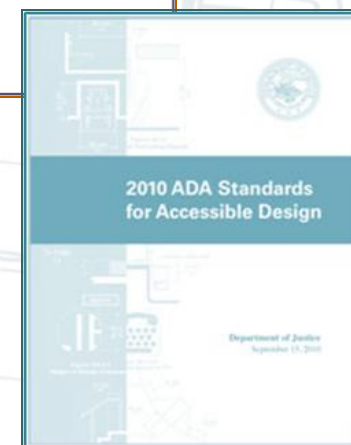

OUT WITH THE OLD... IN WITH THE NEW

On September 15, 2010 the Department of Justice (DOJ) published its final regulations amending the Americans with Disabilities Act for:

- title II (State and local government programs, services and activities)
- and
- title III (public accommodations and commercial facilities)

These regulations clarify issues that have arisen over the past 20 years and contain new and updated regulations, as well as scoping and technical requirements found in the 2010 ADA Standards for Accessible Design.

The newly revised rules specify several compliance dates by which title II and III entities covered by the ADA are required to comply.
