The Atlanta Urban Design Commission reviews plans and projects for historic buildings and districts in the City of Atlanta, as well as for City of Atlanta owned properties and rights of way, works of public art, and parks; all of which effect the aesthetic, cultural and historic quality of the City of Atlanta's urban experience.

Through its annual "Awards of Excellence" competition, the Atlanta Urban Design Commission honors those projects, programs, individuals and organizations that have significantly contributed toward the enhancement of the City of Atlanta's built environment, the preservation of our physical heritage, and the sympathetic balance between the old and the new.

Work considered for an award must currently be in a state of completion or have been recently completed and must be within the City of Atlanta limits. The Commission can limit the number of awards in each category and change the category for an award.

Winning nominations will receive awards at a public ceremony hosted by the Mayor. Winning nominations may have to submit additional materials that are not returned.

One nomination per form. Downloaded versions or copies of the form are acceptable.

12 hard copies of all materials must be included with your submission. All hard copies must be no larger than 8 1/2" by 11", double sided, stapled and no more than seven pages including the nomination form, narrative and images.

One copy of Jpeg files of the all photographic images of the project must be submitted with the nomination. Only 10 photographic images can be submitted for each project.

No e-mailed or faxed copies of any materials or Jpeg files will be accepted.
