Description: The complexity of building envelope designs, use of new materials, and high rate of moisture/air infiltration in new buildings indicate why building envelope commissioning is an essential step in ensuring that buildings remain water-and-air-tight. Addressing the building envelope issues in the early stages of a building construction project saves money and time, and reduces liability for the design and construction team.
