Technician Talk

Q - Is there anything new out there for monitoring extended cycles?

A – The revised CSA standard Z314.3-14 now suggests 4 extended cycles (2 pre-vac and 2 gravity). The prevac cycles suggested are 270°F for 10 min & 270°F for 20 minutes. Work is going on with manufacturers for devices requiring extended cycles to either validate their device for a standard 4 min cycle or for one of the above extended cycles. All extended cycles must be monitored with a PCD that is designed for extended cycles. Check the IFU for your BI to see if they are validated to monitor the extended cycles you use. Remember, the indicator inside the tray also needs to be validated for use with an extended cycle.

Quality Assurance Corner

Q - What do we do with the difficult to clean devices we see every day? Does anyone out there know about them?

A - There is a document available on the CSAO website entitled: Medical Devices Reprocessing Concerns and Recommendations of the Scientific Advisory Panel on Reprocessing of Medical Devices. This document was published in 2006, so, while it is relatively recent, may not include every problem device out there. The document lists problem devices, whether a single use devices is available to replace it, the reprocessing concerns about the device and recommendations on what to do about the device.

As always, follow the device manufacturer's IFU for reprocessing to ensure the devices is as clean/sterile as possible. If you have a problem device, register a complaint with the vendor, send the device to them for assessment, ask for written direction from them to obtain optimal cleaning, keep records of the correspondence with the vendor, and lastly, if possible, don't purchase it. Not selling a device will motivate a vendor to fix the issue. If all else fails and you cannot return it, bring the device to your reprocessing committee for review and probable removal from service. Your reprocessing committee will act on behalf of what is best for patient care.

Just remember, you are not alone with a problem device. There is help out there!

Question Period

Welcome to flu and cold season!! Remember, the best way to prevent getting a cold or the flu is frequent hand washing. It is critical in an MDRD to wash your hands about a zillion times a day. Wash your hands at least:

- >when entering/leaving department
- >before/after eating
- >before/after using the bathroom
- >after coughing/sneezing/wiping nose/touching face
- >during and after removing PPE
- >after picking something up from floor and sending back to decontam
- >when visible soiled
- >and for any other potential contamination
