

Capitol Conference Kickoff. Michael E. Dunn, popular speaker on grassroots advocacy and political action committees, will set the stage for the upcoming events and sessions by "Taking Political Involvement to the Next Level." An overview and new developments with NAA/NMHC's exciting new national public service campaign also will be featured.

Newcomers Orientation. If you're new to the Capitol Conference or want a refresher's course, join us for an overview of how a bill becomes law and the valuable role you play in the legislative process.

Advocacy Education Sessions. Choose to attend two of the following informative sessions—twice as many as in previous years:

- PACS and PAC Fundraising: Raising funds for NAAPAC is critical to the success of NAA's advocacy efforts. This session focuses on different strategies for raising those funds. A panel of your colleagues will lead the discussion with examples of what has worked with their affiliates.
- PAC and Grassroots Advocacy 2.0: In this three-part session, you'll have the opportunity to hear from a series of speakers on topics including turning your Lobby Day meetings into real relationships for advocacy and the next trends and new tools in PACs and grassroots advocacy. You'll also share your current challenges and successes in a town hall work session.
- Maximizing the Impact of Your Advocacy Efforts: Effectively telling your story to impact legislation is key to advocacy success. Learn how to build your story in this interactive, hands-on session and practice effective storytelling with your peers in preparing for your Hill meetings.
- Developing a Strategic Communications Campaign: This can't-miss session tells you how to use communications campaigns to garner the support you need. A Public Affairs Council expert will share secrets on integrating traditional and social media to amplify your messages. Then two of our industries' top PR professionals will tell you how they created their own successful campaigns.

Lobby Day. Wednesday, March 13 is the apartment industry's Lobby Day on Capitol Hill. Join your peers from across the U.S. and meet face-to-face with your representatives in Congress. Use the information you learned during the Capitol Hill Issues Briefing, advocacy education sessions and other events to tell your members of Congress how legislation and regulations impact you and your business. Attendees are responsible for scheduling their visits.

NAA Government Affairs Department Works for You!

We work to promote the apartment industry's public policy interests and protect its business practices. Our work provides a safety net for NAA members so they can focus on what's important to them—the business of providing quality homes for Americans.

At the **federal level**, we partner with the National Multi Housing Council to advocate for a supportive legislative and regulatory climate to benefit our members' businesses. At the **state and local levels**, we analyze legislation, conduct research and provide resources

Our grassroots advocacy network (the Apartment Industry Mobilization Service) represents 60,000 people who voluntarily engage with their elected officials and ensure that constituents' voices on apartment issues are heard and understood. Our political action committee, the NAA Political Action Committee (NAAPAC), supports congressional candidates who represent good government and understand our industry's needs and concerns.
