The Technical Training Instructor will provide technical/job skills training to new and existing employees, as well as participate in the development of new training programs and maintenance of existing training materials. The primary audience for training will be our Field Metering Services employees (field customer service) who perform: a) Company and Customer generated work related to the natural gas meter, b) first response to gas leaks/odor complaints/gas related emergencies, c) turn off / turn on of natural gas service, and d) safe light up of gas appliances. The Technical Training Instructor will also provide appropriate training to area fire departments, first responder organizations, building officials, HVAC & plumbing contractors, pipeline contractors, and community groups. May make recommendations for updates to existing work practices and Standard Operating Procedures, the Operator Qualification Plan, and work procedure improvements. When appropriate, researches governmental regulations and policies and interprets their applicability to gas operations. May act as a first responder to pipeline incidents and participate in root cause analysis activities. May perform inspections/audits to ensure employees are performing jobs in compliance with regulatory and company safety policies and programs. Tests and recommends new tools, equipment and work procedures.
