Canadian Logistics Services Phase II Opens

Canadian Logistics Services, a tenant at the Global Transportation Hub (GTH), announced the grand opening of Phase II of the CLS Distribution Centre. CLS serves Loblaw Companies Limited stores, including the Real Canadian Superstore. The company will inhabit a million sq. ft. warehouse and distribution centre in the GTH which will store and transport 30 million cases of goods each year. The first Phase opened in February of last year.

The GTH, located west of Regina, will facilitate the movement of Saskatchewan goods throughout Canada and the rest of the globe thus making the province a significant partner in the Asia-Pacific Corridor.

Expansion plans on course for Mosaic Potash

Mosaic Potash, the world's third largest producer of potash, is planning a \$6-billion expansion of potash production facilities in

Saskatchewan. Currently, Mosaic produces roughly 12% of the world's potash totaling 10.3 million tonnes per year. Sixteen planned expansion projects in the province will help Mosaic achieve expected production of 16.5 million tonnes of potash annually by 2021. It is estimated that the expansion will add 500 new jobs at the potash mining company.

Joint biofuel project in testing stage

A partnership between Agrisoma Biosciences, the National Research Council (NRC), Honeywell UOP and Saskatoon's Genome Prairie-led Prairie Gold Project is attempting to develop a biofuel blend derived from modified seeds of the Ethiopian mustard plant, Brassica carinata. The heat and drought tolerant plant is being touted as a sustainable jet fuel alternative which would bring a growth in returns to prairie farmers. The project is currently in the process of testing the eco-friendly fuel. If results are positive, the project founders intend on scaling up production in the near future.


- AEECON Group awarded an \$80 million contract for construction on a potash mine.
- Saskatchewan uranium producer Cameco is acquiring NUKEM Energy GmbH, a German trader of nuclear fuel and services, in a \$136-million deal.

Saskatchewan Exports Strong

The first three months of 2012 Saskatchewan saw a 17.2% increase in exports over 2011 corresponding to the second highest percentage increase in the country. The growth can be explained by an increase in world demand for goods produced in the province.
