



## 2014 WRLA Education Rebate Program

### Course Rebate

- Eligibility - WRLA members only
- **\$100 rebate** per participant per WRLA course
  - Level 1: Estimating Fundamentals – Decks and Garages
  - Level 2: Estimating for Residential Construction
  - Level 3: Advanced Estimating
  - Yard Foreman – Operations Manager
  - Retail Business Management Studies Program – Management Skills
  - Retail Business Management Studies Program – Human Resource Management
  - Retail Business Management Studies Program – Financial Management
  - Retail Business Management Studies Program – Inventory Management
  - Retail Business Management Studies Program – Retail Marketing
  - Retail Business Management Studies Program – Purchasing
- **\$50 rebate** per participant per WRLA course
  - Plumbing
  - Electrical

**\$50 rebate** per participant - Forklift, Telehandler, Aerial Work Platform, Skid Steer Loader or Crane/Rigging Operator Cervus Equipment  
Maximum of 20 rebates in total of any combination of above courses per corporate company per WRLA membership year April 1, 2014 – March 31, 2015

**\$250 rebate** per participant - Forklift "Train the Trainer - Cervus Equipment  
Maximum one per corporate company per WRLA membership year  
April 1, 2014 – March 31, 2015.

#### ***Forklift Rebate Deadline***

Submit the rebate form and full payment no later than 30 days from *WRLA invoice date*.

#### ***Course Rebate Deadline***

Submit the rebate form no later than 30 days from course completion date  
Account must be paid in full in order to receive this rebate



## 2014 WRLA Education Rebate Program

### Travel Expense Rebate

- Eligibility - WRLA members only
- One travel rebate submission per participant per WRLA membership year April 1, 2014 – March 31, 2015
- **50% of allowable expenses - up to a maximum of \$500**
- Participant home must be located 100 km (one way) or more from the nearest WRLA course location
- All WRLA courses excluding Plumbing & Electrical and Forklift Training
- Hotel and / or Travel
  - You must remit **ORIGINAL RECEIPTS** with items clearly identified
  - Accommodation, include hotel bills and meal receipts
  - Travel receipts include air fare bill, gas receipts *or* mileage @ .31 per km
  - NO rebate allowed for alcohol, hotel phone, movies or gratuities

The WRLA office will decide the rebate amount as per direction of the WRLA Board of Directors

Deadline – Submit the rebate form and receipts no later than 30 days from course completion date  
Account must be paid in full in order to receive this rebate



*Rebate program may be amended or cancelled at any time at the discretion and direction of the WRLA Board of Directors*
