## TERRY DAVIS TO BECOME PRESIDENT AND CHIEF EXECUTIVE OFFICER OF HOME HARDWARE STORES LIMITED

In 2010 he was appointed Executive Vice-President and Chief Operating Officer and became Chief Executive Officer in 2014.
