



Lodging - US RevPAR +0.5% Y/Y Last Week; Chanukah calendar shift

Transient RevPAR (-0.3%) weaker than Group (+1.4%)

What's Incremental To Our View

Overall U.S. RevPAR was +0.5% Y/Y for the week ending 12/8/2018, per STR, lower than the prior week's result of +3.3%. (2-year stacked RevPAR was +7.3% vs +4.8% in the prior week.) Independent hotels (about 1/3rd of the data set) were +3.5% y/y. Economy (+1.7%) was the strongest chain scale for branded hotels; Upscale was the weakest at -2.4%. Upper Midscale (-1.4%) also underperformed the industry average. Within Upper Upscale & Luxury class hotels, Group (+1.4% vs. +5.6% prior week) was stronger than Transient (-0.3% vs. +2.8% prior week).

Last week's data presented weak Transient results and we believe part of the weakness was driven by the Chanukah calendar shift. In 2018, the first night of the holiday started on Sunday, December 2nd. Chanukah began on Tuesday, December 12th last year.

- Additionally, **during low occupancy weeks** (generally the case in early December -- occupancy was ~ 60-61% both last week and y/y), **there can be more variability in RevPAR given the smaller base of demand.** Weather issues in select markets also adds to the volatility.

Due to the hurricane comparisons, we anticipate continued choppiness of the data for at least the next few weeks followed by a continued harder comp for the 2017 hurricane markets for the next several months.

RevPAR details:

- **Economy was the strongest chain scale.** Upper Midscale and Upscale underperformed by 310 bps and 410bps, respectively: Luxury RevPAR (+1.4%), Upper Upscale (-1.1%), Upscale (-2.4%), Upper Midscale (-1.4%), Midscale (-0.1%), and Economy (+1.7%). Independent hotels (+3.5%) outperformed headline U.S. RevPAR.
- **Within Upper Upscale & Luxury class hotels, Group was stronger than Transient:** Transient segment (individual business and leisure travelers) RevPAR was -0.3% (vs. +2.8% last week) and Group segment RevPAR was +1.4% (vs. +5.6% last week).
- **Boston (+15.1%) was the strongest of the top five markets:** Chicago (-1.8%), LA (-4.4%), NYC (+1.2%), and DC (+0.6%).

What's Inside

Weekly STR results and analysis

- **San Francisco was positive:** RevPAR was +4.9% vs. +11.3% last week.
- **Texas results were down (y/y hurricane comps especially in Houston):** Dallas RevPAR was -5.3% (vs. +2.2% last week). Houston RevPAR was -14.3% (vs. -23.1% last week).
- **Hurricane-impacted markets in FL were mixed:** Miami (+1.7% vs. -6.1% last week); Orlando (-10.8% vs. -13.4% last week).

The stocks: We continue to favor C-Corps over hotel REITs (we favored hotel REITs for the first half of this year). In an environment of low RevPAR growth combined with gradually increasing wages/margin pressures, returns for hotel owners is a major headwind to EBITDA growth. Hotel stocks, but especially hotel REIT stocks, typically work best when there is a spark to RevPAR growth and at this moment we are not seeing such a spark like we did earlier in the year. **We are more favorable on other sectors at the moment, namely cruise lines.**

- For the C-Corps, HLT (Buy) and [Playa Hotels](#) (PLYA, Buy) are among some of our favorites and for the hotel REITs, given its opportunities for self-help margin improvement, we prefer Buy-rated Park Hotels & Resorts (PK, Buy). For the rest of the hotel REITs, following the first half outperformance, we struggle to derive any material upside potential to the stocks even when assuming pro-forma targets with 5% higher EBITDA and giving valuation multiple expansion.
- The (relatively) good news for the hotel REITs is that historically 10 (or less) years into an economic cycle these were stocks that "crashed & burned". At this juncture in our RevPAR intelligence there is nothing to suggest a late cycle "crash & burn" scenario is on the horizon over the next year. Additionally for the hotel REITs, we do not see dividend cuts on the horizon and for 2019 many are heavily exposed to what will likely be the strongest market in the country (San Francisco).

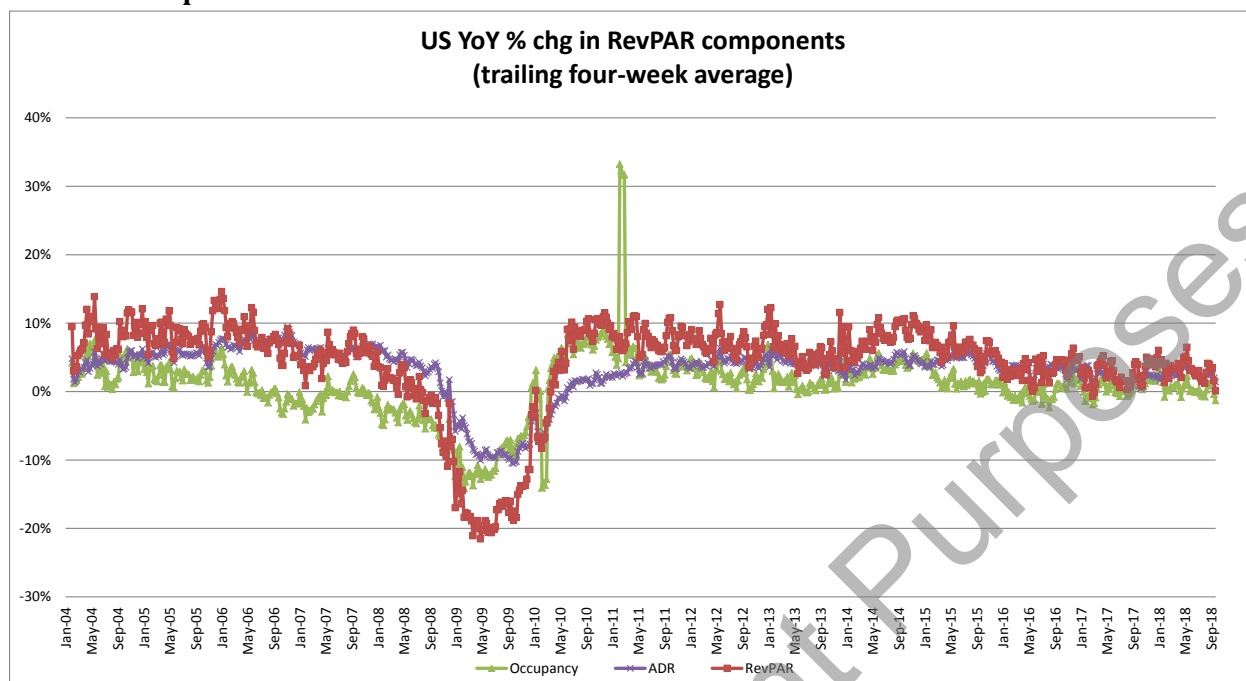

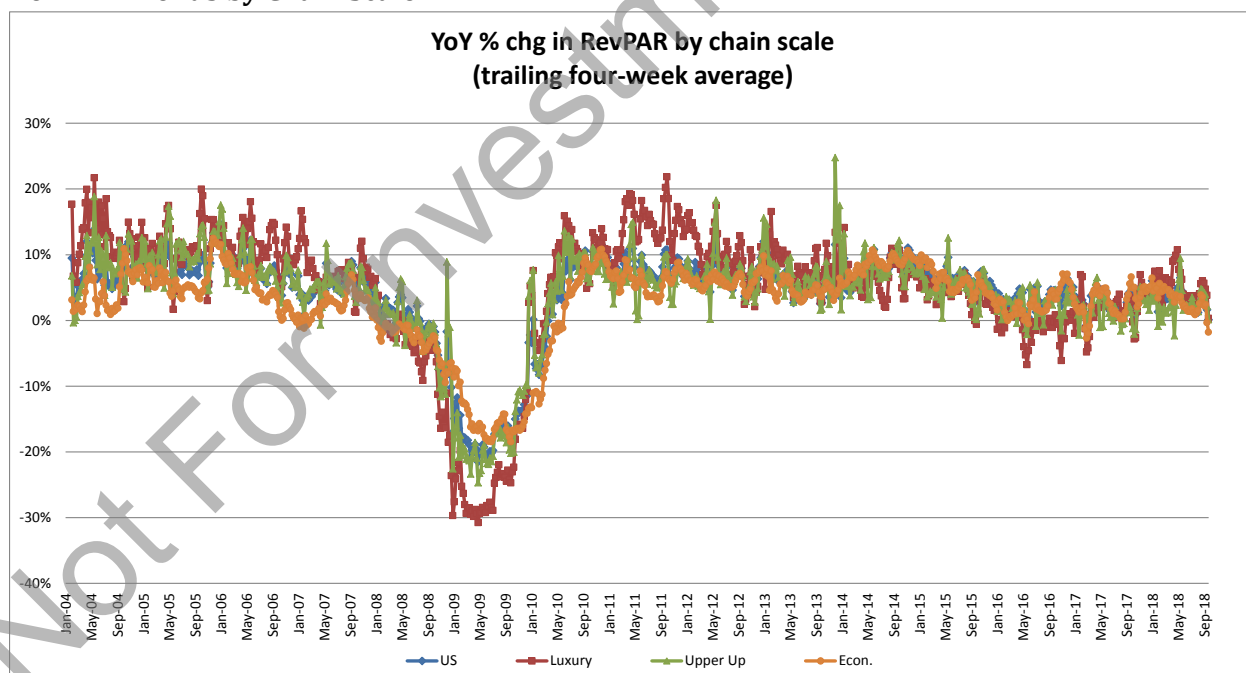

RevPAR Component Trends



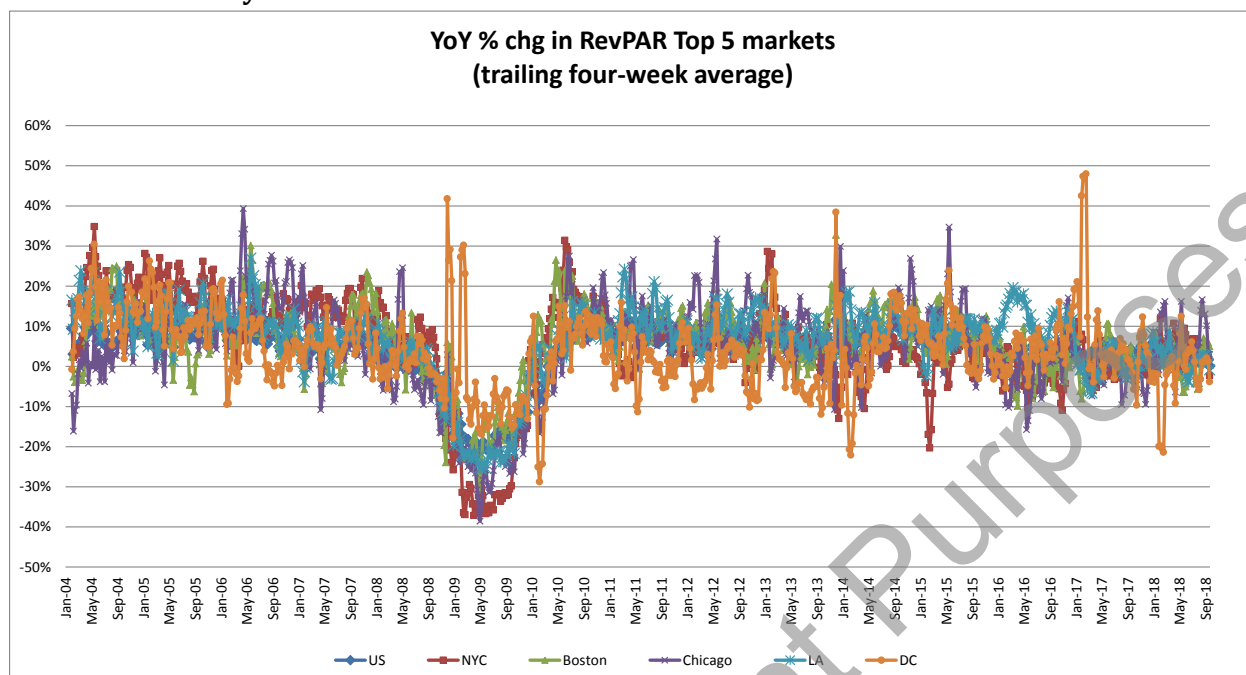
