



Lodging - US RevPAR +1.6% Y/Y Last Week; Clean comp with soft group

Lackluster results not so dissimilar to sentiment at NYU + NAREIT conferences

What's Incremental To Our View

Overall U.S. RevPAR was +1.6% Y/Y for the week ending 6/1/2019, per STR, softer than the prior week's result of +3.1%. (2-year stacked RevPAR was +4.2% vs +6.1% in the prior week.) Independent hotels (about 1/3rd of the data set) were +3.2% y/y. Upper Midscale (+1.3%) was the strongest chain scale for branded hotels; Luxury was the weakest at -0.3%. Midscale (+0.3%) underperformed the industry average. Within Upper Upscale & Luxury class hotels, Group (-4.7% vs. +5.7% prior week) was softer than Transient (+3.0% vs. +2.6% prior week). Headline RevPAR was helped by independent outperformance.

Last week was a relatively clean comp. While Group RevPAR was challenged at -4.7%, looking at the detail by market there may have been some puts/takes on some citywides contributing to the below-normal performance as well as some day-by-day impact from the various sporting events such as the 2018 NHL playoffs and finals.

- Day of week results were down on Friday (-2.1%) although low-to-mid-single digits positive over the weekdays.
- Unusually, Upper Midscale was the strongest chain scale. We do not read anything from a trend perspective into this relative anomaly.

For the month of May, we estimate that full-service branded domestic hotels (the typical Hilton [HLT, Buy], Hyatt [H, Hold], or Marriott [MAR, Hold] hotel) will finish at approximately +2-3% (unchanged from our prior estimate). We estimate that the overall industry will finish +2-3% (unchanged from our prior estimate). Please note that reported monthly results include hotels that are not in the weekly data set.

Last week's RevPAR details:

- **Upper Midscale was the strongest chain scale.** Upscale underperformed by 120 bps: Luxury RevPAR (-0.3%), Upper Upscale (+0.9%), Upscale (+0.1%), Upper Midscale (+1.3%), Midscale (+0.3%), and Economy (+0.2%). Independent hotels (+3.2%) outperformed headline U.S. RevPAR.
- **Within Upper Upscale & Luxury class hotels, Group was softer than Transient:** Transient segment (individual business and leisure travelers) RevPAR was +3.0% (vs. +2.6% last week) and Group segment RevPAR was -4.7% (vs. +5.7% last week).

What's Inside

Weekly STR results and analysis

- **Boston (+18.1%) was the strongest of the top five markets:** Chicago (-0.6%), LA (-1.3%), NYC (+0.9%), and DC (-3.3%).
- **Other relevant markets:**
 - **San Francisco was up (Moscone Convention Center expansion and renovation completed):** RevPAR was +7.8% vs. +9.7% last week.
 - **Houston** RevPAR was -9.4% (vs. +8.3% last week).
 - **Florida markets were mixed:** Miami (-1.2% vs. +2.1% last week); Orlando (+0.8% vs. +6.9% last week).

The lodging stocks: We continue to favor C-Corps over hotel REITS (we favored hotel REITS for the first half of last year) and within C-Corps **WH is our new favorite**, partly due to its underperformance this year vs. **our previous favorite, Hilton**. In an environment of low RevPAR growth combined with gradually increasing wages/margin pressures, **returns for hotel owners is a major headwind to EBITDA growth**. Hotel stocks, but especially hotel REIT stocks, typically work best when there is a spark to RevPAR growth and at this moment we are not seeing such sparks like we did at this time one year ago.

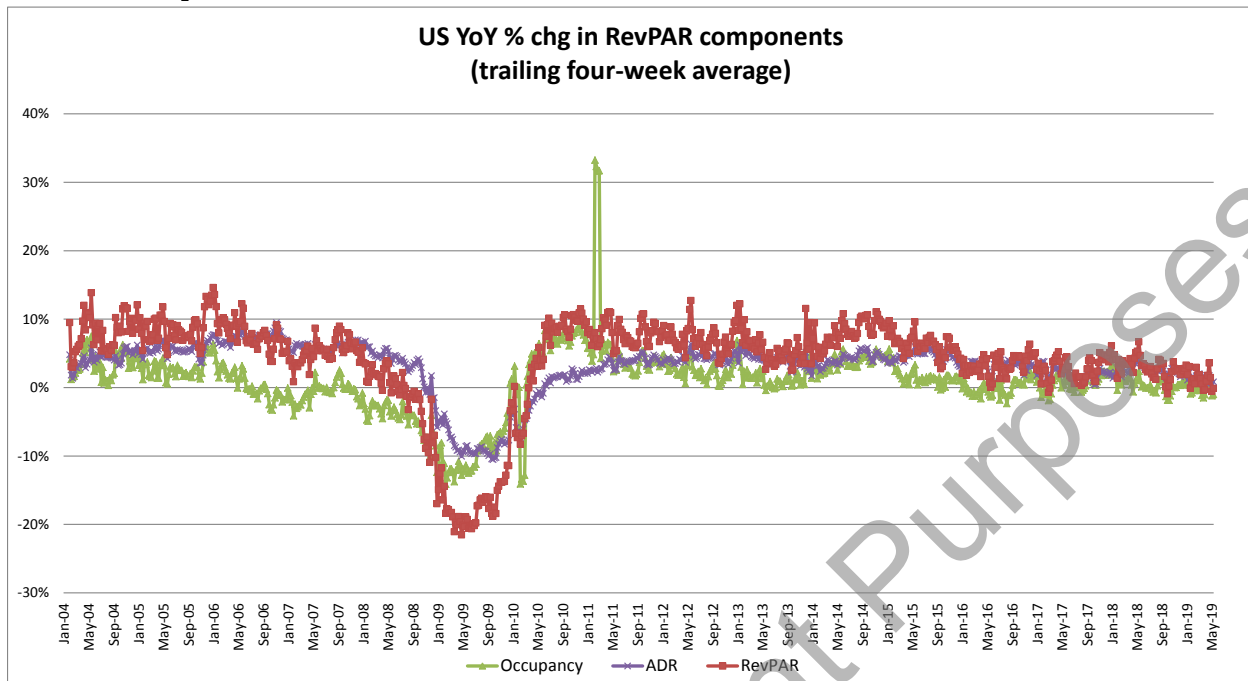

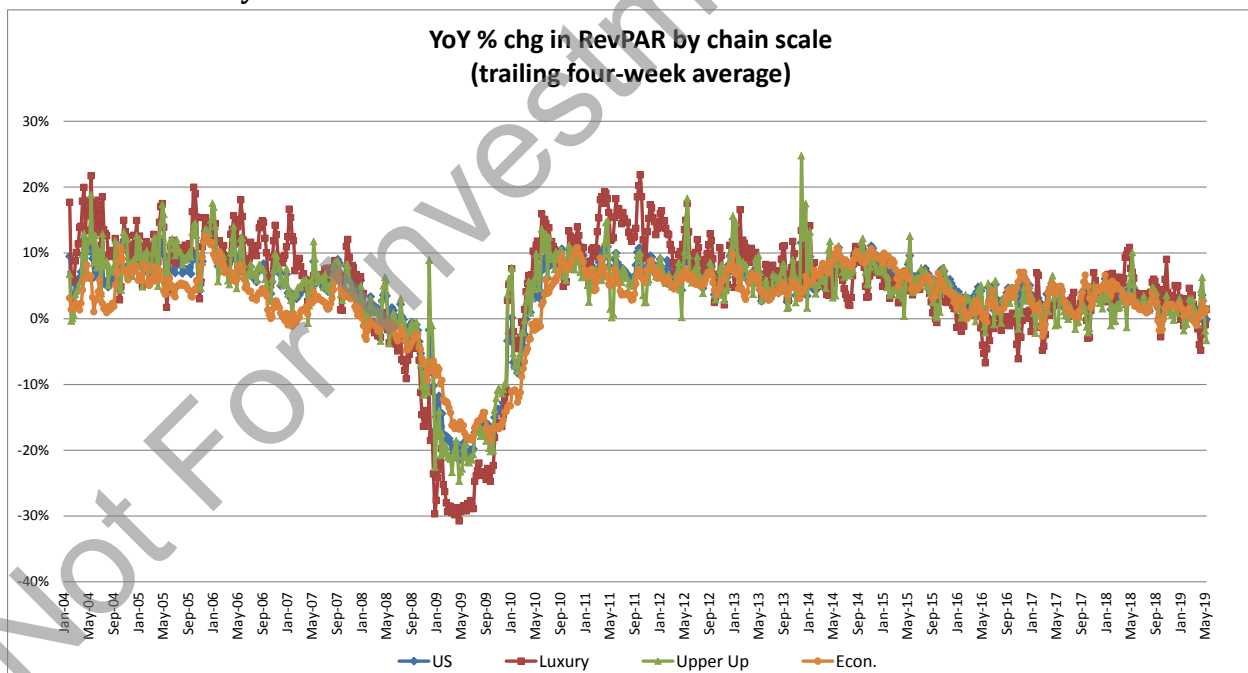

RevPAR Component Trends

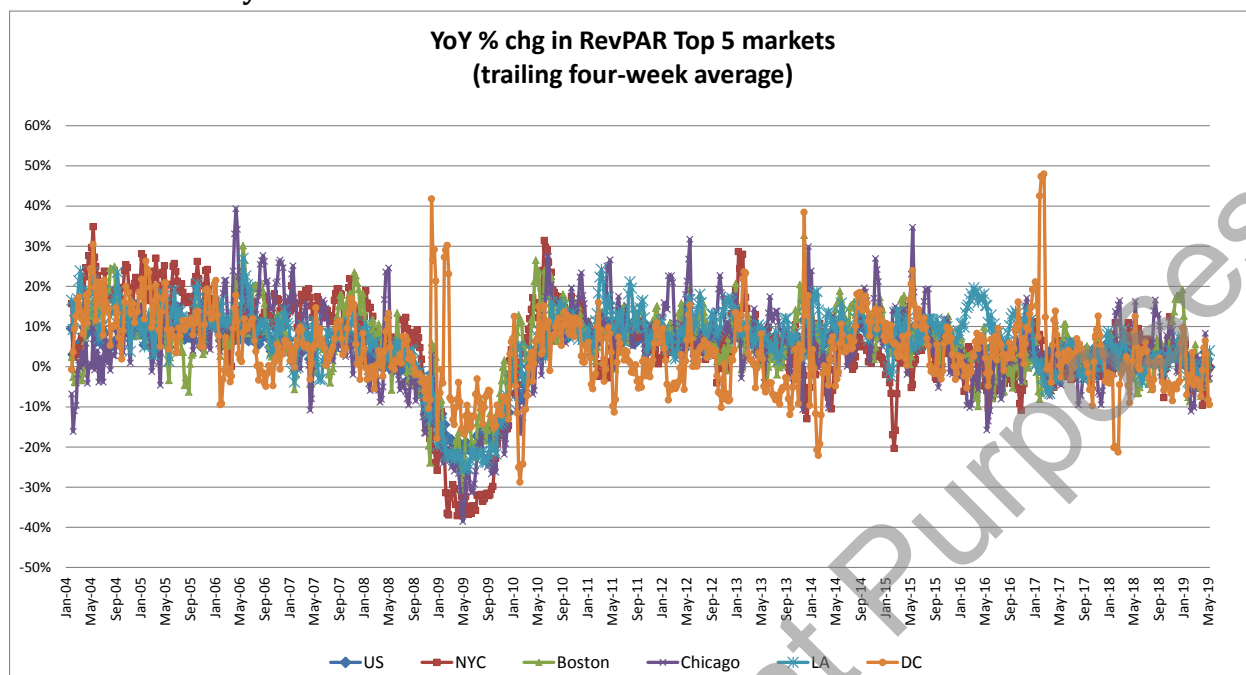

WH: Valuation and Risks

Our price target of \$68 for WH is based on a 13.0x multiple (in line with portfolio quality/RevPAR relative to peers) of our 2020 EBITDA estimate.

Downside risk: slowdown in development opportunities. La Quinta synergies below expectations. La Quinta integration takes longer than anticipated. Macro demand headwinds.

HLT: Valuation and Risks

We apply a blended multiple of 14.8x (10.5x for Owned/leased and 15.0x for Managed/franchised) to our 2020 adjusted EBITDA estimate to derive a 12-month price target of \$101. This multiple is towards the higher end of the historical range of 10x-16x.

Risks include:

Growth trajectory could disappoint. Pipeline growth could either slow down or projects scheduled for construction could be cancelled, which would diminish system growth for the firm and disappoint investors.

H: Valuation and Risks

Our price target of \$82 for H is derived by applying a 13.1x target EV/EBITDA multiple (a blended average of the industry multiples for each business segment) to our estimate for 2020 EBITDA. Our valuation model for Hyatt assumes an owned-hotel 2020 EBITDA multiple of 12.0x and a franchise/management fee EBITDA multiple of 14.0x.

Upside risk: transient and group trends outperform expectations.

Downside risk: ongoing misexecution and volatility.

MAR: Valuation and Risks

Our \$135 price target is based on a 14.8x blended multiple on our 2020E EBITDA. In the parts, we assign a 13.0x multiple of EBITDA to the Owned segment and 15.0x fees EBITDA (the fees EBITDA also includes credit card branding fees, a 10x multiple business) to the managed/franchised business. The multiple is towards the higher end of the historical range of 9-18x.

Risks to our rating and price target:

Upside Risks: Significant U.S macroeconomic improvement results in large recovery in transient corporate demand (and consequential >400 bps RevPAR improvement). Owned assets sell for premium prices relative to MAR expectations.

Downside Risks: 2020 could potentially be a recession year in the US. Geopolitical and policy risks negatively impact lodging demand.

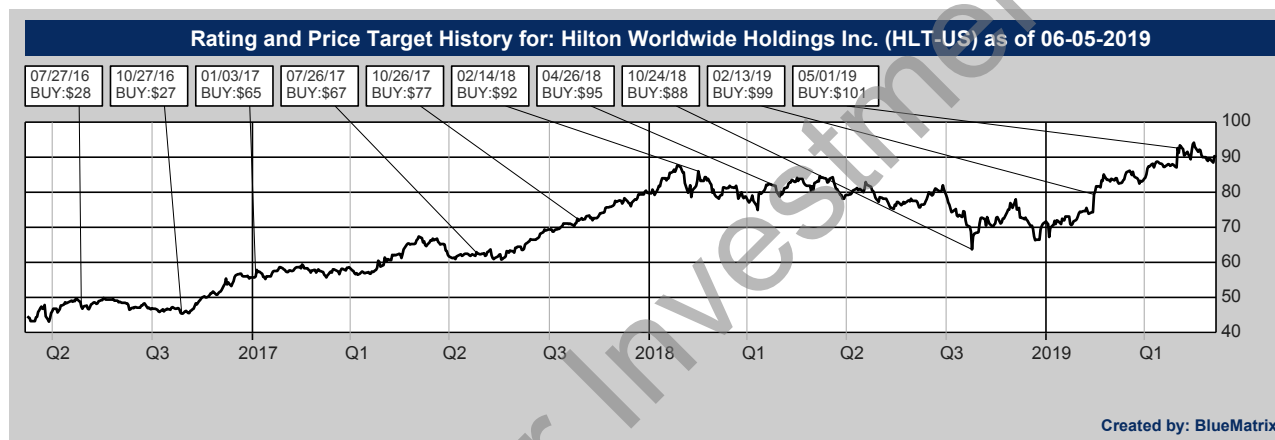
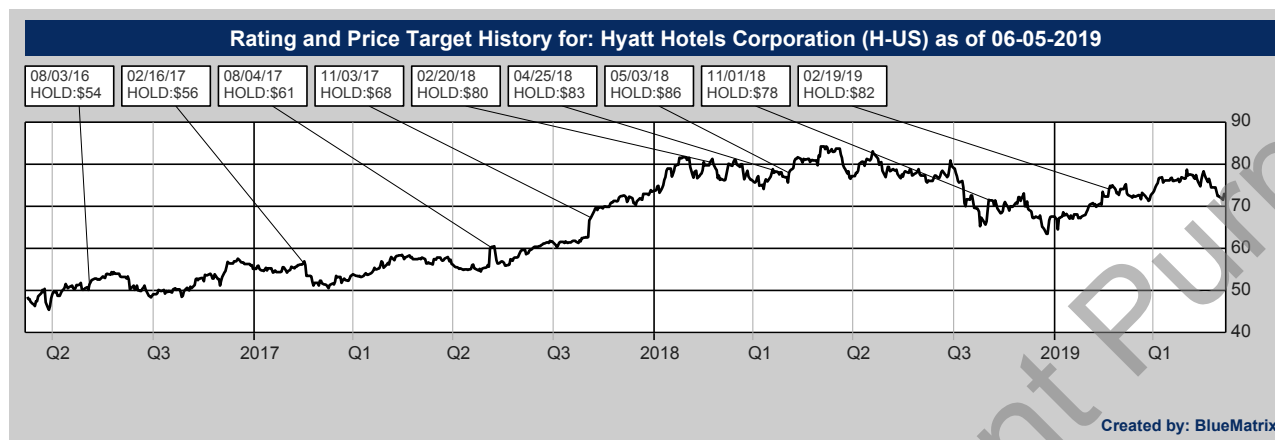

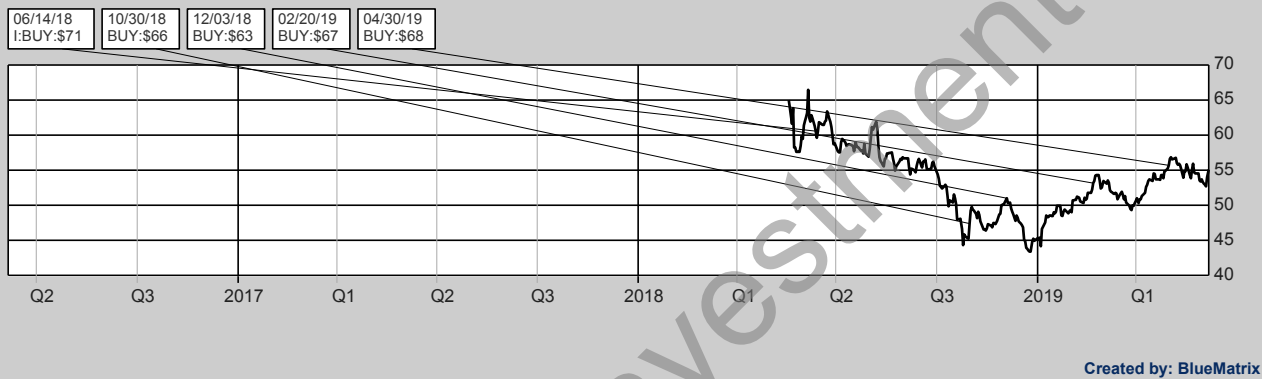
