



Questions

- Did you know studies have shown that firefighters have a higher rate of cancer than the general public?
- Did you know there are controls for the hazards that may increase those risks of cancer within firefighters?
- Did you know if you build awareness of the hazards and controls of firefighter cancer within your department, you could win a reimbursement up to \$5,000 toward the purchase of a washer extractor for your department? Learn more below.

Program & Sponsors:

LGRMS, working in conjunction with ACCG and GMA, wants to encourage the awareness of the hazards and controls surrounding firefighter cancer across the State of Georgia. Thus, we will award two fire departments up to \$5,000 in reimbursement, for the purchase of a washer extractor, if they train at least 80% of their department employees on the NVFC/IAFC - Lavender Ribbon Report. As you know, each firefighter will receive 1-hour training credit because the training was developed by NVFC/IAFC.

Eligibility Requirements:

- 1. Fire department must be a member of GMA's or ACCG's Firefighters' Cancer Benefit Program.
- Complete the application and proof of training documentation. Training must be completed for at least 80% of the department's firefighters (based on insured population).
 - a. Link to: NVFC/IAFC Lavender Ribbon Report
 - b. Link to: One Hour PowerPoint Presentation based on NVFC/IAFC Lavender Ribbon Report
 - c. Link to: Trainer / Instructor Notes for Lavender Ribbon Report
- 3. Application must be submitted, and training must be completed, by November 30, 2020. Your application should be submitted electronically to Dan Beck of LGRMS at dbeck@lgrms.com.

Award and Reimbursement Process:

- 1. On December 1, 2020, LGRMS will review all applications and identify those that meet all eligibility requirements.
- 2. All eligible departments will be separated into two categories: 1. ACCG Members and 2. GMA Members.
- 3. A department from each association will be randomly selected as the winner of the reimbursement up to \$5,000.
- 4. We will notify the winners by December 7, 2020. The winners will have until January 15, 2021 to purchase the washer extractor and provide purchase documentation to LGRMS.
- 5. LGRMS will provide a reimbursement up to \$5,000, based on the purchase documentation.
