### AATA Signs Letter to Congress Addressing Mental Health and Substance Use Disorder Services and Programs

As a member of the Mental Health Liaison Group (MHLG), a coalition of national organizations committed to strengthening Americans' access to mental health and addiction care, the AATA recently added its signature to a letter addressed to the 115th Congress during their contemplation of reforms to health care insurance coverage. The letter urges the preservation of access to crucial mental health and substance use disorder services and programs and protection for the progress that Congress has made on parity under the Paul Wellstone and Pete Domenici Mental Health Parity and Addiction Equity Act (MHPEA), the Affordable Care

Act (ACA), and the 21st Century Cures Act.

## Ethics, Law, and Cultural Competence in Art Therapy

The recent passage of the U.S. state of Tennessee HB 1840 releases counselors and therapists from the ethical responsibility to provide services to clients whose behaviors, therapy goals, or chosen therapeutic outcomes conflict with the counselors' or therapists' "sincerely held principles" or religious beliefs. In support of positions taken by the American Counseling Association and the American Psychological Association, the American Art Therapy Association (AATA) issued a statement that opposes the Tennessee law, which permits discrimination based on claims of religious freedom (AATA, 2016). **READ MORE**

### What's confusing about mental health parity

The Mental Health Parity and Addiction Equity Act has been law since 2008. MHPAEA provided that health plans could not limit mental health or substance use disorder benefits in a way that was more restrictive than how most medical/surgical benefits were limited. This sounds simple enough, but in this year alone there has been a White House task force, voluminous Department of Labor guidance, a SAMHSA best practices manual, and an Energy & Commerce Committee hearing to find out why most people still can't access care.

In 2004, Dan McCleary's mother passed away. "My parents were avid book readers and collectors of art books," the artist told me. "So instead of buying flowers, I told everyone to buy me books."
