On March 21, State Representative Marlene Anielski (R-Walton Hills) gave sponsor testimony before the House Health Committee on behalf of House Bill 557. The bill would grant a license to Art Therapists to practice under the guidance of the State of Ohio Medical Board. "Art therapy has proven to be an incredibly useful tool in dealing with a myriad of issues where many individuals suffer," said Rep. Anielski. Committed to improving mental health awareness and suicide prevention in Ohio, Rep. Anielski has been a passionate supporter of the Ohio licensure effort and spoke at the Buckeye Art Therapy Association's (BATA) Hill Day back in November.

How do you get an injured service member to talk about an injury they don't want to talk about? Give them an art project. "I was like, 'I'm a soldier? You want me to color," said Staff Sgt. Dwayne Gadsden, who was skeptical at first. "It does help," said Gadsden, an Army flight medic who suffers from post-traumatic stress disorder and a traumatic brain injury after being deployed to Iraq three times. **READ MORE**
