- 6. Get involved in education programs through family advocacy groups, hospital outreach programs and community education
- 7. Exhibits at community events and health care fairs
- 8. Submit Request for Proclamations to your mayor and governor

Case Management Week Proclamations

Chapters have been seeking proclamations since 2003. This is an opportunity to engage in a discussion with your local government on case management, and seek public recognition for your industry. You can contact both your City Mayor and State Governor. If you are in a State with multiple chapters, consider working together for the State Proclamation. Continue this recognition by highlighting your proclamation in articles, press releases, media coverage of your events, and inviting the politician to an event during CM Week to formally present the Proclamation.
