#### **Objective**

- Create a fumigation banner that displays the name and phone number of the termite company.
- Provide a visual display where neighbors and potential customers will find more information and details on a termite inspection and fumigation.
- Generate additional business by as much as 20%!

#### **Contest Details**

- Submit photos of your company's banner for entry into the contest.
- All photos <u>must be received by May 31, 2012.</u> Late entries will not qualify.
- Contest winners from 1 year prior are not eligible to enter the following year's contest (i.e. 2011 winners cannot participate in 2012).
- All prior contest winners must submit <u>different banners</u> to be eligible for the current year's contest.
- Banners must be used at multiple job sites (banners cannot be created for contest use only).
- The contest announcement will appear in the *PCOC NewsBriefs*.
- Contest winners will appear in the *PCOC NewsBriefs*.
- Winners of the contest will be featured in the Vikane® gas fumigant newsletter Fumigation Update.
- Contest awards will be presented at the Pest Control Operators of California (PCOC) Annual Convention in San Diego, CA June 21-23, 2012.

#### **Banner Requirements**

- Banners must be at least 4' x 8'. Other common sizes include 3' x 10' and 4' x 12'.
- Banners must state the termite company name and phone number.
- Banners should have a distinguishable logo.
- Termite companies can display banners at all of their fumigation sites.
- Prime contractors who subcontract out their work can have the fumigation company display the banners at their specific jobs.
- Subcontract fumigation companies can support the contest by displaying the banners.
- Banners can only be displayed at jobs using Vikane® gas fumigant.

#### **Photo Submissions**

- Contest submissions will be a sample photo of banners used on actual jobs.
- The photo must clearly show the name and phone number of the termite company.
- If the company is a multi-branch operation, the participating branch location must be noted in the submission.
- Submissions can be made either by the termite company (Branch 3) or the fumigation company (Branch 1).
- Each contest participant MUST be a current PCOC member.
