## CHEMTREC SIGN UP TODAY!

All transporters of hazardous materials are required by State and Federal regulations to have an emergency response telephone number on their shipping papers. This telephone number must be answered by a person knowledgeable about the transported materials whenever a vehicle is on the road.

CHEMTREC usually offers this service for \$1000 for your main location and \$285 for any additional locations. But, as a member of PCOC, you can get this service for only \$125 for the first location and \$75 for each additional location per year. This is protection and peace of mind for you and your customers at a discounted price!

## CHEMTREC SERVICES AVAILABLE THROUGH PCOC

Transporters of hazardous materials are required by State and Federal regulations (49 CFR 172.600-604) (a)(3) to have an emergency telephone number on their shipping papers. This telephone must be answered by a person knowledgeable about the transported materials whenever a vehicle is on the road. Sign up through PCOC with **CHEMTREC** for \$125 for the first location per year, \$75 for each additional location per year. The cost if you contract directly with CHEMTREC is \$1000 for the first location and \$285 for any additional locations. Signing up through PCOC will save you \$875 for the first location and \$210 for additional locations.

CHEMTREC, the CHEMical TRansportation Emergency Center, was established by the Chemical Manufacturers Association in 1971. It provides first responders, the transportation industry, medical professionals, and others with access to information and technical assistance from chemical industry experts for emergency incidents involving hazardous materials. All of their resources become available to you as a CHEMTREC association subscriber.

## **HOW DOES IT WORK?**

- 1. Provide PCOC with a complete list of your main office and any branch locations for listing.
- 2. A list of all the products you transport or use.

On your hazardous materials shipping papers, you list the CHEMTREC telephone number and the statement "To be used only in the event of a chemical emergency involving a spill, leak, fire, exposure, or accident!" If your vehicle is involved in an incident and CHEMTREC is contacted, they will fax a report to PCOC. We will forward that report to you so you may make any required notifications to DPR or the National Response Center. **CHEMTREC** provides a listing monthly to DOT officials of current members.

CMA has a library of over five million MSDSs. Your support is needed to help ensure that they have the information on all regulated products of concern. As a CHEMTREC association member, you may list regulated products you use other than pest control. Regular members may participate.
