## Steps to Becoming an ACE

ACE certification can lead to better visibility, opportunities, and jobs. Why not begin the process of earning your ACE?

### 1. Meet these pre-requisites:

- Hold a current pesticide applicators license.
- Have a minimum of 5 years of verifiable pest management experience, less if a related degree is held.
- Provide two letters of recommendation.
- Adhere to the ACE Code of Ethics.

2. Complete the ESA ACE application process as outlined at <http://www.entocert.org/ace-application-process>, and say VPMA is your proctor, and pay the fee (\$125 - \$150) to ESA. ESA will process applications within the 30 day window.

3. Complete this VPMA ACE Prep Course registration form and pay the \$175 fee. Deadline: **June 19, 2019.**

*If you are taking the ACE Exam, you must bring a wifi enabled laptop with you.*
