### **IHSA highlights struck-by hazards**

*Struck-by* is the term that Ontario's prevention system uses for the various injuries that occur when workers are hit—or struck—by tools, materials, equipment, or vehicles. Just like falls, struck-by is a leading cause of injury in the industries that IHSA serves.

IHSA is highlighting this hazard in this month's *2-Minute News* to ensure that workers, supervisors, and employers have the knowledge they need to reduce or eliminate this hazard from worksites.

### **Health and Safety Advisory: *Struck-By Incidents and Heavy Equipment***

For workers on foot, a busy jobsite where heavy equipment and machinery is constantly on the move can be a very dangerous place. Every year, workers are killed and injured from being struck by heavy equipment and machinery. For workers in the homebuilding, ICI, heavy civil, or road building industries, there is an increased risk of this hazard.

Follow the guidelines in this booklet to reduce struck-by incidents when working around heavy equipment, reversing vehicles, and moving machinery.

## **IHSA has developed a new training program — *Suspended Work Platform System — Installers course***

IHSA has created a new training program to meet the needs of those who install and inspect suspended access equipment. It is designed to meet the training requirements outlined in the updated (2016) Construction Projects regulation (O. Reg. 213/91, s. 138.1 (3)).

This program teaches participants how to safely install and inspect a suspended work platform system or a powered boatswain's (or bosun's) chair.

Participants will learn how to read and use a roof plan and work plan, assemble a suspended work platform system in accordance with the manufacturer's instructions, and inspect the assembled system.
