CPA Designation and Pathway

A Chartered Professional Accountant (CPA) is a trusted advisor on financial and business matters. Being a CPA isn't only about taxes and numbers. You can build on any of your strengths - like strategic or analytical thinking, leadership and technical ability - to pursue a career in any sector that interests you with the foundation and expertise the CPA designation provides.

The CPA certification program is designed to ensure that students going through it build a strong foundation of ethics, knowledge, and skill. The CPA designation is earned through completing the graduate-level CPA Professional Education Program (CPA PEP) in addition to relevant practical experience.

The nationally developed and provincially delivered CPA certification program consists of:

- Academic prerequisites with specific area coverage
- The CPA PEP, which culminates in the Common Final Examination (CFE)
- Recognized, relevant practical experience totaling 30 months



CPA PROFESSIONAL EDUCATION PROGRAM (CPA PEP)

The CPA PEP is the graduate-level program that makes up the educational portion of the CPA certification program. It consists of modules that are delivered using a blended learning model that combines online learning, self-study, classroom learning and teamwork. The program is designed to enhance future CPAs' ability to apply professional knowledge and values in a professional context.

A CPA designation can still be an option for students who are planning on pursuing a degree in a subject outside of business or planning to keep their options open. To get started on the CPA designation, they will need to complete 120 credit-hours or equivalent degree from a college or university.

What this means for you: If students are unsure of their future, want to keep their options open or have already decided on a program not in business, finance, or accounting, they may still pursue a CPA designation upon graduation.




Career Opportunities
