



2019 BOARD OF DIRECTORS APPLICATION

The Transportation Intermediaries Association Board of Directors adopted the following procedures for Members seeking to run for a seat on the TIA Board of Directors. The TIA Board is comprised of At-Large Seats and Conference Chairs. At-Large Seats are elected by the Members for a term of three years. Conference Chairs are elected by the Members for a period of two years. Elections are held prior to TIA's Annual Conference. The Nominating Committee receives and reviews all applicants. The Nominating Committee receives and reviews all applicants. The Nominating Committee is charged with putting forth a slate of candidates to the Membership that meets the needs of the Association and maintains a Board that is representative of the size, profile, and scope of services offered by the Membership. The Board meets three times per year: at the TIA Conference in the spring, at the TIA FlyIn in the summer, and at the TIA Executive Leadership Forum in the fall.

Criteria for TIA Board Members:

- A member of the Association in good standing
- Holds a position of authority within the Member company, and is able to bind the company
- Understanding of the North American 3PL marketplace and its needs
- Willingness to commit the time, talent, and resources necessary to serve
- A team player that works well in a group
- Listens well and is thoughtful in considering issues
- Significant previous involvement in TIA
- No unresolved ethics complaints
- Willingness to serve without financial reimbursement or remuneration
